## TERMS AND CONDITIONS FOR THE SUPPLY OF ELECTRICITY TO A LOW VOLTAGE CUSTOMER BY N.U.R. DISTRIBUTION SDN. BHD. (407806-X) (the "Utility")

These terms and conditions apply to customers taking electrical supply at low voltage i.e. single phase 230 volts or three phase 400 volts. The leaflet "General Information Relating to Supply" is available in all offices of the Utility.

## IT IS HEREBY AGREED BY THE PARTIES TO THIS AGREEMENT AS FOLLOWS:

(1)	The Utility agrees to supply electricity to the Customer and the Customer engages the Utility to supply electricity to the premises located at the address stated in the application by the Customer for such supply (the "Premises") subject to the Electricity Supply Act 1990 (Act 447), Regulations and Rules made thereunder and the terms and conditions below.				
(2)	The Customer agrees to pay the <b>Tariff*</b> from time to time charged by the Utility, together with the goods and services tax payable thereon and such other taxes, tariffs, duties or charges that may be imposed by any federal, state or local authority, for the supply of electricity to the Premises, subject to a maximum level of supply of kilowatts (kW).				
(3)	The Utility shall install all the necessary equipment up to and including the meter (the "Equipment") for the supply of electricity to the Customer PROVIDED THAT the Equipment shall always remain the property of the Utility. The Customer shall, in respect of the installation of the Equipment by the Utility, pay to the Utility a connection charge contribution in the sum of RM prior to the connection of supply.				
(4)	The Customer shall pay a monthly minimum charge of RM commencing on the date on which supply is connected, if the monthly consumption charge falls below such minimum charge.				
(5)	The Customer shall, prior to the connection of supply, pay a deposit of RM(the "Deposit") to the Utility which the Utility may apply towards:				
	(a) the settlement of any accounts or unpaid amounts due by the Customer to the Utility for the supply of the electricity to the Premises;				
	(b) any cost incurred, for loss or damage of or to the Equipment belonging to the Utility or otherwise, as a resul of the Customer's negligence or fault.				
(6)	All costs incurred on the Premises, additional to that specified under Clause (3) above and peculiar to the Customer for the proper installation of the Equipment for the supply of electricity, shall be borne by the Customer. In the interest of safety and good electrical practice, the Customer's electrical installation shall comply with current approved standards and all electrical installations shall be carried out by a contractor who is registered with the Director-General of Electricity Supply Malaysia or his successor thereof, from time to time.				
(7)	Service or replacement of parts of the Equipment due to the normal wear and tear caused by the continued use of the Equipment shall be borne by the Utility. All other service or replacement costs shall be borne by the Customer.				
(8)	The Utility and its authorised agents/servants shall be allowed entry to the Premises or the Customer's property during normal working hours or such other hours for lawful purposes, including:				
	(a) the reading, checking and replacement of meters;				
	(b) the installation, testing, checking and repair of the Equipment.				
(9)	The Customer agrees to settle in full all bills from the Utility for the supply of electricity to the Premises, within the time period stipulated in such bills. Upon default of the aforesaid, the Utility may disconnect the supply of electricity to the Premises without notice to the Customer and the Customer shall bear any subsequent fees for re-connection or otherwise.				
(10)	The Deposit shall remain always at or above the stated amount and the Customer shall reimburse the Utility for al

electrical consumption by the Customer.

amounts applied by the Utility in accordance with Clause (9) so that the Deposit kept with the Utility shall always remain at or above the required amount. The required amount shall equate to the charge for two months average

- (11) The Power Factor in some installations may need correction; see Paragraph 7 of the leaflet "General Information Relating to Supply".
- (12) In the event that a Customer of the Utility installs and maintains an electricity generator whether it is intended to supply all or part of the Customer's load or to act as stand-by to all or part of the Customer's load, the Customer shall not connect this generator without the knowledge of the Utility. The Customer must also comply with the requirements of the Director-General of Electricity Supply Malaysia or his successor thereof, from time to time.
- (13) If the Customer has applied for a temporary supply of electricity, the Customer shall pay the total cost of the connection and will be charged at the applicable tariff rate appropriate to their category plus a 25% surcharge on the relevant bills rendered. This agreement for the supply of a temporary load shall be time restricted.
- (14) The Utility does not accept any responsibility for any loss or damage caused to the Premises or the property of the Customer as a result of the installation, testing, checking, maintenance or repair of the Equipment or the supply of, or failure to supply, electricity unless such loss or damage is caused by the gross negligence of the Utility or its authorised agents/servants in carrying out their proper and authorised duties. Under no circumstances shall the Utility be liable for any indirect, incidental, consequential or punitive damages or losses (including any loss of revenue or loss of profit).
- (15) The leaflet "General Information Relating to Supply" in section 8, generally outlines the procedures to be adopted where a customer requests the Utility to carry out a meter check.
- (16) The Customer may terminate this agreement for the supply of electricity to the Premises at any time, upon giving at least three (3) working days' notice in writing. The Customer shall remain liable for all electricity charges up to and including the date of termination.
- (17) The Utility may terminate or curtail the supply of electricity to the Premises at any time if such supply to the Premises shall damage or affect the equipment of the Utility or disrupt the supply of electricity to other customers to which the Utility supplies electricity or constitutes a danger to any person or property or for any reason beyond the control of the Utility which results in such termination or curtailment being unavoidable or necessary.
- (18) The Customer shall bear the stamp duty in respect of this agreement.
- (19) The Utility reserves the right to vary the terms of this Agreement at any time throughout the duration of this Agreement to take into account any changes in law which affects the supply of electricity by the Utility to the Customer.
